

## **Minutes of Leesburg Township Regular Meeting**

### **Monday, April 5, 2021**

The Trustees of Leesburg Township met in a regular session.

Members present: Chairman Jeff Robinson, Vice-Chairman Kevin Dotson, Fiscal Officer Mellisa Weigand.

Jeff Robinson called the meeting to order at 7:30 p.m. The trustees reviewed the March 1, 2021 meeting minutes. Kevin made a motion, seconded by Jeff, to approve the minutes. The motion passed unanimously.

#### **Old Business:**

Pathmaster had a technician come out and get the speed light indicator. It will be fixed and replaced when done.

The trailer on John's property is occupied once again. He is trying to find out from his neighbor the intention for the trailer.

Jeff participated in a zoom call regarding potential solar farm installation in and around the township. Samsung is the company initiating the projects. Trustees will stay informed regarding the potential project.

The flagpoles that were ordered for the two cemeteries were delivered. The Trustees will work on arrangements to get the flag poles in the ground. The target date for install is Memorial Day.

#### **New Business**

Deputy Mitchell did not have any news to report. Ben asked for more frequent patrolling in Magnetic Springs by the officers.

Thayne reported on the Estep property to Jeff. He is still working with the post office to retrieve proof that Mrs. Estep signed for her legal paperwork that was delivered via USPS.



Ben informed the Trustees that the Zoning Commission is meeting one more time this month to finalize the new zoning rules. He is gearing up to start cemetery maintenance for the season.



The Union County Engineer ground stumps at Hopewell Cemetery and back filled the spots. We will send them a thank you note for their efforts.


