The Trustees of Leesburg Township met in regular session at the Leesburg Township Fire/Road Maintenance and Storage Facility at 6:00 PM.

Others in attendance were: Fire Chief, Jim Hall, Zoning Inspector Ben Laird, Rick Smith, North Union School District Superintendent, and Holly Rast of the Union Co. Health Department.

The meeting was called to order by Chairman, Gary Cunningham.

Election of new officers for the year 2008 is as follows: Nomination of William Lowe - Chairman, Jeff Robinson - Vice Chairman. Motion by Gary Cunningham to accept the officers as nominated. Seconded by Jeff Robinson. Vote: Robinson (yes), Cunningham (yes) and Lowe (yes). (Resolution # 2008-1)

Minutes of the meeting held December 17, 2007, were read and approved. Gary Cunningham made the motion to accept the minutes as read. Seconded by Jeff Robinson. Vote: Robinson (yes), Cunningham (yes) and Lowe (yes)

Old Business:

The Trustees talked about the signs that need to be placed at the pond on the new facility grounds. And decided when these signs are made there should be new signs made for the cemeteries at the same time.

Zoning Inspector, Ben Laird, reported that there was new dumping at the Ivan Speakman property and the Trustees requested Laird contact Speakman and request removal of all junk.

New Business:

Fire Chief Jim Hall said there was nothing new with the Fire Department but did request advise on internet service for the Department.

Bill Lowe asked Fire Chief Hall for support from the Department on getting the word out to help get the upcoming levy passed. Hall advised they would be glad to do what was required.

Holly Rast of the Union County Health Department was in attendance and announced she would like to attend the meetings on a quarterly basis just to answer questions and update the Trustees on what is new with the Health Department. The Trustees thanked Holly for her interest in the Township and invited her to attend as often as possible. Bill Lowe inquired about the Home Sewage Treatment plan and Holly was unable to answer but would be glad to research the plan and get back to Bill. She did say that in her opinion that in the next three years the State of Ohio would be taking over control of these requirements.

Rick Smith, Superintendent of North Union Schools, attended the meeting to advise and explain the addition/improvement for the North Union Schools and to answer any questions that may arise. Smith announced that the levy for these improvements would be on the upcoming ballot and would be a permanent levy. Smith also explained that the Magnetic Springs Elementary School Building would be demolished in the Spring/Summer of 2009.

Bill Lowe and Jeff Robinson both expressed an interest in a right of first refusal on the property the school is currently occupying and Smith assured them that he would bring this request before the School Board at their next meeting.

Jeff Robinson moved we continue using Jean Smith as clerk for the Zoning Boards and again pay Jean \$100 per Zoning meeting and we remind Jean (by way of a letter) that she needs to copy Fiscal Officer, Annette Chapman, on all Zoning correspondence and minutes. In addition each fireman will be continue to be reimbursed \$10 per run and \$5 per meeting at the end of 2008. Motion seconded by Gary Cunningham. Vote: Robinson (yes), Cunningham (yes) and Lowe (yes). (Resolution # 2008-3)

Gary Cunningham moved that Sexton, Tom Chapman, be paid \$250 for the year 2008 to mow Pine Lane cemetery. Jeff Robinson seconded this motion. Vote: Robinson (yes), Cunningham (yes) and Lowe (yes). (Resolution # 2008-4)

Trustees and Clerk's salaries will be increased by 2.8% for cost of living as directed by the Ohio Revised Code for 2008.

Review of the 2008 Appropriations ensued and the suggested figures were presented by Fiscal Officer Chapman. The Trustees also reviewed the 2008 Certificate of the Total Amount from All Sources Available for Expenditures, and Balances. Fiscal Officer Chapman will finalize numbers and have them ready for final approval at the January 21st meeting.

The Trustees of Leesburg Township met in regular session at the Leesburg Township Fire/Road Maintenance and Storage Facility at 6:00 PM.

The following members were present: Gary Cunningham, Jeff Robinson, and Clerk, Annette Chapman.

Other's in attendance: Assistant Fire Chief, Kevin Dotson, Fire Chief, Jim Hall, and Zoning Inspector, Ben Laird.

The meeting was called to order by Chairman, William Lowe.

Old Business

Jeff Robinson made a motion that the Township purchase an additional refrigerator for the Fire Department to replace the refrigerator that is currently in the Fire House bay. Gary Cunningham seconded this motion. Vote: Robinson (yes), Cunningham (yes) and Lowe (yes). (Resolution # 2008-5)

The Trustees discussed with Fire Chief Hall, the new role of Assistant Fire Chief/Station, which will be held by Malcolm Manville. Hall was in agreement that Malcolm has been a big asset and deserved the title.

Chief Hall updated the Trustees on the Volunteer Fireman, John Crane's accident. Hall reported all has been settled.

Jeff Robinson reminded the group that the next payment on the Richwood EMT Contract is due in March 2008 in the amount of \$3500.00.

New Business:

After discussion on the adaptors for the pumps in the pond, Jeff Robinson made a motion that Jim Hall purchase whatever adaptor and caps are needed to make the process as user friendly as possible. Gary Cunningham seconded this motion. (Resolution # 2008-6) Vote - Cunningham (yes), Robinson (yes) and Lowe (yes).

Jeff Robinson moved the Trustees accept the 2008 Maintenance and Repair of Roads Resolution from the Union County Engineers Office. Gary Cunningham seconded this motion. Vote: Robinson (yes), Cunningham (yes) and Lowe (yes). (Resolution # 2008-7)

Bill Lowe suggested the Trustee get the Community Clean-up day on the calendar. After discussion, it was decided that clean-up day will be April 12th and will be at the new Township facility, manned by the Volunteer Fire Department.

Gary Cunningham resolved that the old fire house in Magnetic Springs, Ohio, as been given to the Village Council of Magnetic Springs, Ohio, and that all fire trucks and usable related equipment have been transferred to the new fire house. There remains an amount of outdated, broken or obsolete items and trash of no value for use to the Township or Fire Department.

Cunningham also resolved that the remaining items have a value of less than \$2500.00. Trustees resolve that for the labor of the clean out of the old firehouse, the items be donated to the Leesburg Township Volunteer Firefighters Associate, a charitable non-profit group of the Township, and any proceeds in the hauling and selling of any scrap metal go to this group. Resolution seconded by Jeff Robinson. (Resolution # 2008-8) Vote - Cunningham (yes), Robinson (yes), and Lowe (yes). This resolution was passed with a unanimous roll call vote.

Clerk, Annette Chapman, presented the 2008 Certificate of the Total Amount from All Sources Available for Expenditures, and Balances. After review Trustee Jeff Robinson moved Trustees accept the Certificate of the Total Amount from All Sources Available for Expenditures and Balances and said Certificate be filed with the Union County Auditor's Office. Motion seconded by Gary Cunningham. (Resolution # 2008-9) Vote - Cunningham (yes), Robinson (yes), and Lowe (yes).

Clerk also presented the year 2008 Appropriations. After review and adjustment, Trustee Jeff Robinson moved Trustees accept the 2008 Appropriation and they be filed with the Union County Auditor's Office. Motion seconded by Gary Cunningham. (Resolution # 2008-10) Vote - Cunningham (yes), Robinson (yes), and Lowe (yes).
