Minutes of Leesburg Township Meeting
Held Monday, January 5, 2015**

The Trustees of Leesburg Township met in regular session at the Leesburg Township Fire/Road Maintenance and Storage Facility at 7:30 PM.

The following members were present: Bill Lowe, Jeff Robinson, and Clerk, Annette Chapman.

Others in attendance were: Asst. Fire Chief, Malcolm Manville, Corey Schalip, Mike Carl, Mellisa Weigand, Union County Sheriff Deputy and Ben Laird.

The meeting was called to order by Chairman, Bill Lowe.

Minutes of the meeting held December 15, 2014, were read and approved. Jeff Robinson made the motion to accept the minutes as read. Seconded by Bill Lowe. Vote: Robinson (yes), and Lowe (yes)

Election of new officers for the year 2015 is as follows: Nomination of Jeff Robinson as Chairman and Gary Cunningham as Vice-Chairman. Motion by Bill Lowe to accept the officers as nominated. Seconded by Jeff Robinson. Vote: Robinson (yes), and Lowe (yes). (Resolution # 2015-1)

Old Business:

The Union County Sheriff Deputy attended the meeting and announced that the Township monthly report will start coming to the Township via email. Bill Lowe asked about setting up a house watch for his neighbor who is currently out of state.

Discussion on whether or not the Cemetery Maintenance position needs to put out for bid ensued. It was decided that Fiscal Officer Chapman should contact the Thayne Gray from the Prosecutor's office and ask for guidance. Once Thayne responds, if a bid needs to be posted, Bill Lowe moves the Job Description from 2014 for the Cemetery Maintenance position (attached) be posted. Bid would be opened at the February 2nd meeting. Jeff Robinson seconded this motion. Vote: Robinson (yes), and Lowe (yes). (Resolution # 2015-2)

Life Force was the next topic up for discussion, again we are looking to the Prosecutor's office for advice. Chapman will inquire to see if Thayne has been contacted by Chris of Life Force.

New Business:

Jeff Robinson moved we continue using Jean Smith as clerk for the Zoning Boards and again pay Jean \$100 per Zoning meeting. Jeff also moved we continue paying both Zoning Boards members \$10 per meeting. In addition Zoning Inspector pay will continue at \$150 per month. Bill Lowe seconded this motion. Vote: Robinson (yes), and Lowe (yes). (Resolution # 2015-3)

Bill Lowe moved Leesburg Township continue paying Fire Chief, Jim Hall, \$150 per month along with \$10 per run and per meeting and pay both Assistant Fire Chief/Mechanics, Kevin Dotson and Malcolm Manville, Assistant Fire Chief/Station, \$600 per year and \$10 per run and per meeting. In addition each fireman will continue to be reimbursed \$10 per run and \$5 per meeting at the end of 2014. Mike Carl, who was appointed Medical Director for the Fire Department in Nov. of 2014, will be paid \$600 per year along with \$10 per run and per meeting. Motion seconded by Jeff Robinson. Vote: Robinson (yes), and Lowe (yes). (Resolution # 2015-4)

Bill Lowe moved that Malcolm Manville stay at \$12 per hour again this year for his work on maintenance and care for the Township facility. Motion seconded by Jeff Robinson. Vote: Robinson (yes), and Lowe (yes). (Resolution # 2015-5)

The price of lots at all cemeteries is \$250 for in township and \$500 for out of township. This will not change for 2015.

The Trustees and Fiscal Officer's salaries for 2015 were discussed. Fiscal Officer Chapman will review the new salary chart and report back at the January 19th meeting according to the State of Ohio's pay chart and according to the Ohio Revised Code for 2015.

Zoning Inspector Ben Laird reported a couple new building permits for December had been completed.

The Lee Manville family sent a very nice Thank You note for the dedication ceremony at the Magnetic Ball Fields held to dedicate shelter house in memory of Lee.

Bill Lowe moved that again this year the Township cover the cost of Annual Township membership fees for all Trustees, Fiscal Officer, Fire Chief Hall, along with Zoning Inspector Laird. This will allow them to attend the Annual Conference if they so choose. Jeff Robinson seconded this motion. Vote: Robinson (yes) and Lowe (yes). (Resolution # 2015-6)

Bill Lowe moved we accept the IRS maximum allowance for mileage for 2015. Jeff Robinson seconded this motion. Vote: Robinson (yes), and Lowe (yes). (Resolution # 2015-7)

Bill Lowe made a motion to hire a Court Reporter for ALL Zoning Appeals meeting for 2015. Jeff Robinson seconded this motion. (Resolution # 2015-8) Vote - Robinson (yes), and Lowe (yes).

Bill Lowe made the motion to continue paying Jim Hall for janitorial duties at the Township Hall at the rate of \$140 per month for 1 year for general cleaning. Jeff Robinson seconded this motion. (Resolution # 2015-9) Vote - Robinson (yes), and Lowe (yes).

Fiscal Officer provided Payroll Certification sheets (time sheets) for 2015 which will need to be completed monthly by each Trustee as well as the Fiscal Officer. Bill Lowe made the motion to pay Trustees 85% out of Gas Tax and 15% out of General Fund. Motion seconded by Jeff Robinson. . (Resolution # 2015-10) Vote - Robinson (yes), and Lowe (yes).

Review of the 2015 Appropriations ensued as presented by Fiscal Officer Chapman. The Trustees also reviewed the 2015 Certificate of the Total Amount from All Sources Available for Expenditures, and Balances. Fiscal Officer Chapman will finalize numbers and have them ready for final approval at the January 19th meeting.

The Fire Department members where in attendance to provide specific needs for the 2015 appropriations for the Fire Fund. They discussed several items that need to be replaced a couple of which were; life packs which could cost the Township up to \$30,000; and turn out gear of up to \$18,000.

At the conclusion of these discussions and with no further business, Bill Lowe moved we adjourn the meeting. Motion seconded by Jeff Robinson. Vote: Robinson (yes), and Lowe (yes)

Other's in attendance: Fire Chief, Jim Hall, Corey Schalip, Mike Carl and Sylvia Zimmerman.

The meeting was called to order by Chairman, Jeff Robinson.

Minutes of the meeting held January 5, 2015 were read. Bill Lowe approved the minutes. Seconded by Gary Cunningham. VOTE: Robinson (yes), Cunningham (yes), and Lowe (yes).

Old Business

Fiscal Officer Chapman reported receiving an email from Thayne Gray from the Union County Prosecutor's office that stated he has been trying to reach Chris from Life Force but that she has been out of the office. Chapman will request that Thayne reach out again prior to the February 2nd board meeting and if there is no resolution to the questions on the contract, Thayne is to invite Chris to join him at the Township meeting on the 2nd.

The Cemetery Maintenance position was the next order of business. Gary Cunningham moved the Township contract with Ben Laird for 3 years at \$8500 per year for Cemetery Maintenance (job description will be the same as last year and a copy is attached). Bill Lowe seconded this motion and will provide a new contract at the February 2nd meeting. Motion seconded by Jeff Robinson. (Resolution # 2015-11) Vote - Cunningham (yes), Robinson (yes), and Lowe (yes).

Mike Carl provided a quote for the replacement Life Pack in the amount of \$26,407.20. This quote was showing a trade in of \$1000 for the current unit. The Trustees are not sure they should trade in for that little in return. Carl provide information on a 3 year and 5 year lease to purchase the Life Pack. After discussion, it was decided to table until the contract with Life Force was worked out and the Trustees had an idea of what dollars would be coming in, if any.

Corey Schalip reported the Township was not selected for the Fire House Subs grant.

Old Business Cont'd

Mike Carl also reported that purchase of the axe, nozzles and chain saw have been made for the Fire Department as instructed by the Trustees.

New Business:

The 2015 Code Red contact was the first order of new business. Bill Lowe made a motion to pay the \$500 for this year's contact with the Union County Sheriff's department. Gary Cunningham seconded this motion. Motion seconded by Jeff Robinson. (Resolution # 2015-12) Vote - Cunningham (yes), Robinson (yes), and Lowe (yes).

Bill Lowe made a motion the Township pay any fees, costs and mileage for attendance to this year's Annual meeting in Columbus, Ohio. Gary Cunningham seconded this motion. Resolution # 2015-13) Vote - Cunningham (yes), Robinson (yes), and Lowe (yes).

Sylvia Zimmerman attended the meeting to announce she would be opening up the Magnetic Springs Café in the near future. Zimmerman asked that the Trustees keep their ears open for anyone in the Township who might be interested in opening up a new small business in the Magnetic Springs area. She would like to be an encouragement to those people.

Zimmerman also thanked the Trustees and Fire Department again for their help in making the General Grant event last August a success.

Jeff Robinson reported the south end speed indicator sign was not working due to the abundant ice/snowfall. Robinson charged the unit and reported it is working again. He did report the door to the box was in need of replacement. Bill Lowe will call the manufacturer and see if just the door could be replaced.

Fiscal Officer, Annette Chapman, presented the 2015 Certificate of the Total Amount from All Sources Available for Expenditures, and Balances. After review Trustee Gary Cunningham moved Trustees accept the Certificate of the Total Amount from All Sources Available for Expenditures and Balances and said Certificate be filed with the Union County Auditor's Office. Motion seconded by Bill Lowe. (Resolution # 2015-14) Vote - Cunningham (yes), Robinson (yes), and Lowe (yes).

Chapman also presented the year 2015 Appropriations. After review and adjustments, Trustee Bill Lowe moved Trustees accept the 2015 Appropriation and they be filed with the Union County Auditor's Office.

Motion seconded by Gary Cunningham. (Resolution # 2015-15) Vote - Cunningham (yes), Robinson (yes), and Lowe (yes).

With no further business, motion to adjourn was made by Gary Cunningham, seconded by Jeff Robinson. Vote - Cunningham (yes), Robinson (yes) and Lowe (yes).

A community Liaison Committee is needed with the contract. This committee will consist of the three Township Trustees, Fiscal Officer, Fire Chief and EMS Coordinator. Bill Lowe moved the Trustees sign the approved contract with Life Force Management for EMT billing services as negotiated by the Union County Prosecutor's office. Gary Cunningham seconded this motion. (Resolution # 2015-17) Vote - Cunningham (yes), Robinson (yes), and Lowe (yes).

The contract will be forwarded to Life Force Management, Chris Knapp, following the conclusion of this meeting.

New Business:

Fire Chief Hall reported a slow start to the year for the Department, which is good news.

Corey Schalip reported the Fire Department will hold a Pancake Breakfast on February 28th at the Township facility.

Zoning Inspector Laird announced nothing new to report.

The Engineer's Office presented the 2015 Equipment, Labor and Material rates. Gary Cunningham moved the Township accept the Union County Engineer's Maintenance and Repair of Roads Resolution for 2015. Bill Lowe seconded this motion.
