



Minutes of Leesburg Township Regular Meeting Monday, February 5, 2024

The Trustees of Leesburg Township met in a regular session.

Jeff called the meeting to order at 7:00 p.m. The trustees reviewed the January 15, 2024
meeting minutes. Bill made a motion, seconded by Kevin, to approve the January
minutes. Motion approved.

Old Business

No word from Fisher Excavating on the house tear down.

Post cards are in the mail for the February 13 meeting regarding the sewer lines in
Magnetic Springs.

New Business

Wezlynn Davis was at the meeting to inform about and discuss her running for State
Representative.

Chad gave an update on the government website he is creating for the township. He will
make a payment for the website and the Township will reimburse him. Chad will become
Mayor of Magnetic Springs beginning March 1, 2024.

Resolution 2024-1 states that Leesburg Township is trading six lots of land in Magnetic
Springs to use for their proposed sewer project. In return, Leesburg Township will get a
sewer line installed to a specified location at the Leesburg Ball Park. Leesburg Township
will not be responsible for the legal fees of this transaction. Bill made a motion to accept
this resolution, seconded by Kevin, motion passed unanimously.



Bill found a new company to use for clean-up day recycling. A 40-yard dumpster taken to Sims Recycling will cost \$285 and three 15-yard dumpsters will cost \$125 each. Bill made a motion, seconded by Kevin, to use this company. Motion passed unanimously.

Jeff had a conversation with Thayne regarding headstone foundations at the cemetery. Thayne says we could let people pour their own footers as long as we have a representative from the township present. We are responsible for the footer if we delegate who puts it down. We may want to choose a length of time to guarantee work.

Jeff says the Union County Commissioners office is looking for legal council to represent them in the Samsung solar plans. They will have a meeting once one is found.

Nigel had two Leesburg Township residents asking about manipulating their existing structures. Nigel informed both of the zoning policies.

The Union County Engineers sent Leesburg a bid sheet for construction of the culvert on Hall Rd. Jeff made a motion, seconded by Kevin, to accept the bid. Motion passed.

Jamie Patton attended the meeting to talk about his campaign for re-election as Union County Sheriff. Tom McCarthy was also in attendance to speak about his running for Union County Commissioner.

The F.O. circulated warrants, purchase orders, vouchers and receipts for trustee approval. Kevin made a motion, seconded by Jeff, to adjourn the board meeting. Motion passed unanimously.
